4. FIRST-AID MEASURES

Inhalation: Remove person to fresh air. If irritation occurs or symptoms develop, get medical attention. **Skin contact:** Remove contaminated clothing. Wash skin with soap and water. If irritation develops and persists, get medical attention. Launder clothing before reuse.

Eye contact: Immediately flush eyes with water while lifting the upper and lower lids. Get medical attention if irritation persists.

Most important symptoms/effects, acute and delayed: May cause mild eye irritation. Prolonged skin contact may cause irritation and drying of the skin. Ingestion may cause gastrointestinal distress with nausea and diarrhea. Inhalation of mists may cause upper respiratory tract irritation.

Indication of immediate medical attention and special treatment, if necessary: Immediate medical attention is not generally required.

5. FIRE-FIGHTING MEASURES

Extinguishing media: Use water fog, foam, carbon dioxide or dry chemical to extinguish a fire involving this product. So not use solid water stream as this may spread the fire.

Specific hazards arising from the chemical: Product is not flammable or combustible but may burn in a fire. Combustion products are hazardous and may include carbon, nitrogen, sulfur, phosphorus and molybdenum oxides.

Special protective equipment and precautions for fire-fighters: Firefighters should wear positive pressure self-contained breathing apparatus and full protective clothing for all fires involving chemicals. Cool fire exposed containers with water.

6. ACCIDENTAL RELEASE MEASURES
